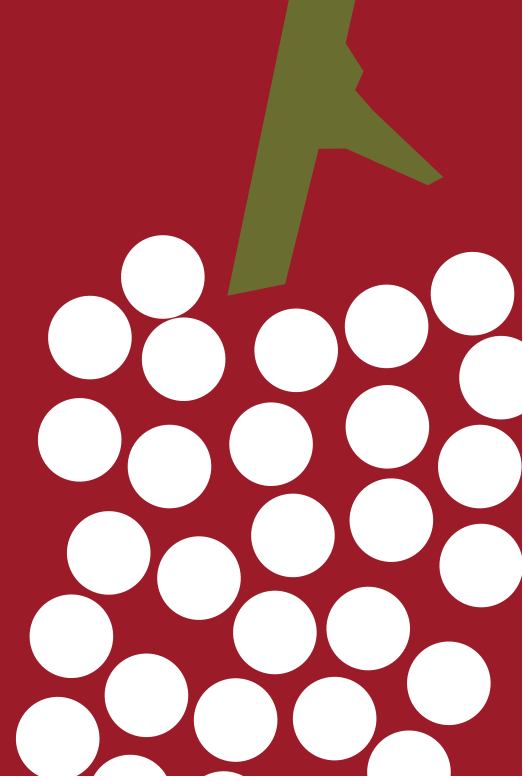




# 4<sup>th</sup> Annual Art In The Park!

# ARTIST AGREEMENT

---

## Application to reserve artist space at the Art in the Park events at Grizzli Winery on August 15 & 16, 2020.

Between: Grizzli Winery (hereinafter called Grizzli) AND:

Company or Artist Name, hereinafter referred to as the Artist

### The Parties Agree As Follows:

1. Only one Artist is permitted to operate per artist space and application. The Artist will not permit another business to operate from their artist space or give their artist space to another business without the approval of Grizzli.
2. Grizzli will provide the Artist with a location within the event area which will approximate a 10x10' footprint.
3. The Artist shall be responsible for maintaining the cleanliness of the area to which they have been allowed space to operate.
4. Music played from Artist spaces is not permitted.
5. The Artist is responsible for their equipment (extension cords, tables, chairs, display materials, etc.)
6. **Event location:** The Artist acknowledges that the event will be held fully outdoors, as Grizzli Winery is committed to keeping our staff, vendors and guests safe. The Artist is responsible for securing their own tents or umbrellas. The Artist may be on either a paved or grassed area.

*Agreement to Location clause*
7. The Artist shall load in NO EARLIER than 9:30AM on Saturday, August 15, 2020.
8. The Artist shall complete set up BY 10:45AM on Saturday, August 15, 2020.
9. The Artist shall operate their booth from 11:00AM to 4:00PM on August 15 & 16 unless otherwise approved by Grizzli. The Artist shall

*Agreement to Liability clause*
10. not pack up and/or leave the event area prior to 4:00PM each day.
10. For any unforeseen circumstances that happen during Grizzli business hours (10:00AM-6:30PM), please contact Grizzli's event supervisor.
11. The Artist may coordinate another trusted individual to oversee their space during event hours. Grizzli staff are not responsible for overseeing the Artist display at any time.
12. The Artist may choose to move their display indoors overnight or to leave it outside. Grizzli incurs no responsibility for losses or damages during this time. Grizzli's business hours extend from 10:00AM-6:30PM during the event dates.
13. Grizzli will not be responsible for loss or damage to any property. Accordingly, the Artist shall take all necessary precautions to protect their valuables.
14. **Liability Waiver:** Applicant hereby assumes any and all responsibility for all known or unknown damages, injuries, losses, judgements and/or claims whatsoever that may occur to any artist, and/or his or her property while participating in the Art in the Park events at Grizzli. The Artist releases from liability: Grizzli Winery, the organisers, and sponsors. The Artist is wholly responsible for and required to have their own liability insurance.
15. The Artist is responsible for their cash, credit card and debit card security, and payments.

# ARTIST AGREEMENT *continued.*

Grizzli is not able to process any transactions, give change, or offer cashback to artists. There is no ATM on site.

**16. Photo Release:** I hereby grant Grizzli permission to use my likeness and artist display at Art in the Park in a photograph, video, or other digital media ("photo") in any of its marketing materials now and into the future, without compensation for their use. I waive any right to inspect or approve the finished product in which the photo appears. I hereby hold harmless and release Grizzli Winery from all claims.

17. Artist Applications and Agreements must be submitted by Friday, July 10, 2020 via email.
18. The Artist must meet all health and safety and fire regulations.
19. The Artist gives consent to the Art in the Park team to disclose their name, company name and/or telephone number to those persons inquiring about their product(s).

- **20. Artist fees: New for 2020.** There is now a deposit to secure space for the Artist to participate in Art in the Park.
- **Deposit:** \$50 for the weekend to secure your space.
- This deposit will be refunded after the event if the Artist appears on the days agreed upon. If the Artist cancels at the last minute or fails to show up during the agreed upon times, the deposit will not be refunded.

*Agreement to Artist Deposit clause*

21. Grizzli will monitor closely all health advisories from the B.C. and Federal Governments, and adhere to any requirements or regulations. If Grizzli is required to cancel Art in the Park, we will advise Artists as soon as this decision is made. Grizzli will refund all paid Artist Fees, but is not liable for any other costs or lost income incurred by Artists.

By signing, the Artist hereby agrees to and will adhere to all conditions outlined in the 2020 Art in the Park at Grizzli Winery Artist Application and Agreement, specifically including the installed Event Location; Liability Waiver; and Artist Fees sections.

If the Artist does not agree to or adhere with the above conditions, Grizzli has authorisation to decline said Artist participation in the 2020 Art in the Park events, and other future events hosted at Grizzli.

I am eligible, have read, understand, and agree to comply with all Art in the Park rules and regulations as specified by Grizzli Winery as per the above rules and regulations.
